Board of Directors Update, continued

This year, the Board has made a number of appointments to fill open positions. In the interests of transparency, we would like to take a moment to explain who filled which position – and why those people were selected.

- *Jayne Hardwick* has been appointed as Treasurer. Dana Duke, our elected Treasurer, resigned this summer due to an increased demand on her time. Jayne recently completed a review of our financial documents, as mandated by our Bylaws, and so she had at least a cursory knowledge of the Association's finances. She was the obvious choice to finish Dana's term as Treasurer, given her knowledge and experience.
- *Stephanie Eller* has been appointed as Vice-President. Emily Mattox, our elected Vice-President, has stepped into the Presidency following the completion of Deanna Snell's one-year appointment. Stephanie is an elected Director on the Board already; therefore, stepping into the new position is easier for her than for anyone from outside the Board who would need to get up to speed on all the Board's ongoing projects. Stephanie expressed her willingness to be appointed as Vice-President directly to the Board instead of through the Nominations and Elections Committee. This appointment may have come as a surprise to many but appointments are not required to go through the Committee's process. Stephanie is planning to run for election as Vice-President this summer for the 2019 term.
- *Krista Adelhardt* has been appointed as a Director, filling the position Stephanie vacated following her appointment as Vice-President. Krista expressed her willingness to be appointed to the Board (at the time as Vice-President) to the Nominations and Elections Committee, but she was clear she did not want to run for election – she was volunteering for a one-year appointment only. For succession planning purposes, the Board felt it made more sense to ask Krista to be a Director instead of Vice-President. Krista is not planning to run for election for the 2019 term.

ZIMS CARE & WELFARE,

The final piece in a comprehensive approach to animal welfare

I have kept records and managed databases for 20 years at Peoria Zoo. I can't remember a time when the publication of a new association standard generated so much discussion as the release of the 2019 AZA animal welfare accreditation standards. Upon review, we felt we needed to develop a new process to assess and document animal welfare and wellness by creating an Animal Welfare Plan for every animal in our collection—overwhelming, to say the least.

Development

First, we agreed upon an institutional animal welfare philosophy based on Mellor and Beausoleil's five domains model of four physical domains (Nutrition, Environment, Physical Health and Behavior); and one mental domain (negative and positive subjective experiences), which together give rise to an animal's welfare status.

Next, we set goals for our program, with an overarching goal to be a transparent **proactive** and **reactive** process to identify and evaluate animal welfare.

We tackled the **proactive** process first by creating a comprehensive evaluation form comprised of a series of welfare indicators under each of the five domains. These comprehensive evaluations are scheduled monthly with multiple evaluators and evaluation results are captured, compiled and compared in our in-house access database. Final assessment data is then added to ZIMS using the Care and Welfare module templates—also built around the five domains model (to my immense relief). I cannot imagine starting over or using different terminology as we worked to implement all of these changes.

The **reactive** process was a little more difficult for us to develop. Initially we tried to complete the same comprehensive evaluation for species/individuals that had experienced a facility or life event. We found it difficult to complete a full evaluation with multiple evaluators each time one of these events occurred. Then came the ZIMS Care and Welfare module!

After reviewing the welfare indicators available from Species360, along with our built in template system, everything clicked and we realized we were already recording and discussing welfare indicator information every day. Keepers were already recording indicators such as: *percentage of the diet consumed, fecal quality, weight, level of training engagement, changes in demeanor* etc.; we just weren't using the term **welfare indicators**. We further realized we were already asking keepers and veterinary staff to record specific sets of indicators for specific situations: *an animal in quarantine, an animal in a new enclosure, change in exhibit mate, etc.* We just weren't utilizing the **Care and Welfare templates** to record the information.

Implementation

Implementing our Welfare Plan is the responsibility of the Animal Management Team (AMT). Peoria Zoo's AMT meets every morning to discuss husbandry, transfers, medical issues, etc. with welfare assessments now a regular part of these daily discussions.

We quickly developed standard sets of indicators to record animals in quarantine, animals who lost an exhibit mate, or animals with an existing injury. The true beauty of the ZIMS Care and Welfare module templates is each template is customizable for the individual animal and his/her situation. In Peoria, we decided specific situations would dictate frequency of assessment records. We also feel it is extremely important for keepers to review these indicator results on a regular basis; for this reason, we created welfare indicator templates for the keepers in

ZIMS notes and observations allowing keepers to review indicator results on their Daily Reports. The information from the keeper's note is then added to the Care and Welfare module, using individual *Care and Welfare templates*.

It probably goes without saying, that utilizing ZIMS to record this data certainly satisfies the last part of our goal to operate a program that is a **transparent** process to identify and evaluate animal welfare. Utilizing the reporting function from ZIMS Care and Welfare allows us to share and review indicator results.

We've been operating our new and improved plan for a few months now and animal welfare indicators are now discussed and reviewed every day. Requests for new indicators to be recorded may come from anyone on staff—often veterinary staff, curatorial staff, or keeper staff. The list of indicators we record is very fluid as is the frequency of the recordings. The flexibility of the ZIMS Care and Welfare module has been integral in developing and executing our plan for promoting optimal animal welfare.

I would like to thank all 23 of the facilities that supported the creation of the Care and Welfare module—it has truly changed the way we operate.

A first at the Zoo de Granby, an Andean condor chick!

After several years of failed breeding attempts, 2018 will be very memorable for the institution with the hatch of the first Andean condor chick. Already pair bonded at the San Diego Zoo - Safari Park since 2002, the couple arrived at the Zoo de Granby in 2010. Although the female and the male are respectively 18 and 29 years old, it is their first time as parents. Andean condors are sexually mature at the age of 7 and can reproduce up to the age of 50, which is very promising for the future. A camera has been installed in the nestbox which allows the zookeepers of the South American sector to monitor the nest without disturbing the couple. Thanks to the camera resolution, we were able to identify the small crest on the head of the chick which confirms that it is a male. Everyone is extremely proud of this significant accomplishment!

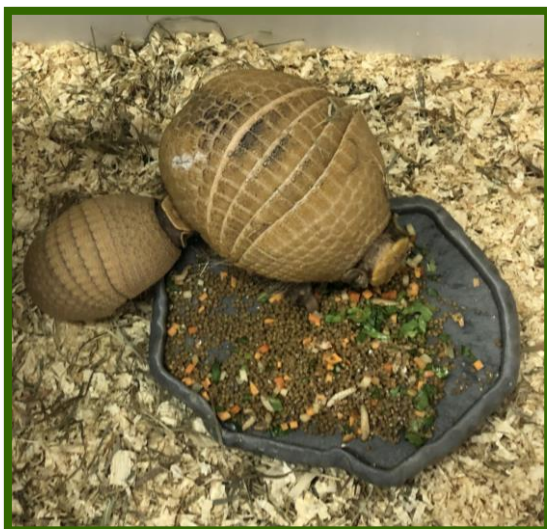
