### SHARING RECORDS DISCUSSION FROM LISTSERVE

Towards the end of 2020, many institutions began receiving information regarding a pilot program that enables veterinary advisors to view shared data through ZIMS. The prospect of this new feature was promising but brought about an interesting discussion on security and management of access.

Conceptually, the program should provide increased security compared to the "old way" of sharing records with veterinary advisors. Up until now, we have either emailed a (sometimes massive) PDF file or provided access to an entire institution to enable records sharing for specific individuals. With PDF files, there's no way to regulate where the file goes once it's been sent. It could be forwarded on in a million different directions with no end in sight – how terrifying! Enabling institutional access offers the veterinary advisors convenient and constant access to the animals they advise. However, it also grants their entire institution access to the records of those individuals at your institution. This means a lot of hands in the cookie jar, and if you have cookie jars at home, you know how devastating this can be. This pilot program offers more security in an effort to maintain institutional confidentiality. The records are accessed by an individual with their own mnemonic, which means no other individuals at their institution have the same access.

Going forward, we must consider how this information can be utilized. Should formal agreements be written by regional associations to dictate exactly what the information can be used for, or should the formal agreements be written by each participating institution instead? Can we prevent misrepresentation of data? How can we prevent unauthorized records use in third party research? Stay tuned as we dive deeper into this new ZIMS feature! Records sharing is an excellent tool to help facilities further promote animal welfare and improve conservation strategies. Laying a firm foundation now will prevent unmitigated problems going forward and provide us all with happy veterinary advisors and registrars.

### **BRIEF HISTORY OF THE ANNUAL INVENTORY**

If you are interested in a brief history of the annual inventory, a.k.a. year end report, here's how I remember it:

Very few zoos kept inventories of their collections before the mid-1970's, though many did submit numbers to the "Census of Rare Animals" published annually by the International Zoo Yearbook (IZY). Under the leadership of T. H. Reed, W. Conway and R. Reuther, the National, Bronx and Philadelphia zoos got together as a group; they called themselves the Zoo East Species Trust (ZEST) and it was the precursor of the SSPs, etc. (The first meeting of the group was at Philly and Ralls and Ballou presented their seminal findings on inbreeding there.) One of the first ZEST activities was to compare the three collections, looking for species in common and seeing which species might be managed as a single unit. - a novel idea at the time. In order to compare the collections, N. Duplaix at Bronx, pulled together a list of species we had in common (I recall that it was a huge task as only NZP routinely published an inventory). At the same time, T. H. Reed was president of the IUDZG (International Union of Directors of Zoological Gardens, now WAZA), and, as such, he had advocated the use of the Rotterdam Zoo annual inventory format - sort of an accounting balance sheet - as the standard for all zoos around the world. He wanted the ZEST zoos to be an example and a result was a paper in the IZY\*. Another result was an emphasis on keeping records of animals as individuals, a concept that was just beginning to be adopted by zoos. With zoos producing annual inventories and sharing xerox copies it was possible to compare all sorts of things, including reproductive success and mortality rates, even before the universal adoption of ISIS. When ISIS ARKS first came out, one of its earliest goals was to be able to produce these annual inventories as a report in the standardized balance sheet format. The format enables zoo managers to assess their collections and successes on a yearly basis.

The anniversary of Earth Day, April 22, 1970, seems an appropriate time to mark an important, exciting and fertile decade in zoo history.

## HAPPY GRADUATION DAY TO TWO OF THE ZOO'S PATIENTS

Happy Graduation Day to Two of the Zoo's patients from the Miller Park Zoo in Bloomington, Illinois—a pair of Snow Leopard cubs!

The male and female, both born on August 4, 2020, were brought to Omaha about two months ago to undergo physical therapy for "swimmer's syndrome". With this congenital condition, the cubs were unable to tuck their legs beneath their bodies to walk normally.

While in Omaha, the cubs were in physical therapy three times a day, seven days a week.

"We just continued what they started and were fortunate enough to have the staff and resources

to allow us to provide more intensive therapy," said Dr. Sarah Woodhouse, Director of Animal Health. "It's so amazing what zoos can accomplish for animals when they are willing to work together."

Dr. Woodhouse, along with Darlene Klimek, Senior Keeper of animal Health and the cubs' primary keeper in Omaha; and Jay Tetzloff, Miller Park Director and Snow Leopard Species Survival Plan Coordinator, addressed Omaha media last week to

This effort demonstrates our commitment to help save the species."
