Professional Development Committee

Training Certificate Program (TCP)

The Board of Directors approved the delivery of the ZRA Training Certificate Program to fully transition to Thinkific's Learning Management platform by October of 2022. In the interim, ZRA renewed with the San Diego Zoo Global Academy/CypherWorx through that same timeframe to continue delivering the current modules so there is no disruption in service. Lillian Moore is leading this transition and will act as the account manager and guide the author teams to reformat the current content to start creating courses in Thinkific. She will work with the Board to identify the first courses to transition to the new system. Rae continues to administer the current TCP in the interim.

We are seeing an uptick in the number of monthly purchases of the TCP more closely resembling the registrations we saw in the first year of deployment.

2021 - As of 6/21/2021, 33 purchases and related revenue is \$4790 2020 - 28 total purchases and related revenue or \$4340

Total number of learners purchased since inception of the TCP on 10/18/2018 - 103Total revenue generated since 10/18/2018 is \$20,951

ICRM

PDC leadership met to revise and combine ICRM and TCP programs into the Professional Development and Training Scholarship guidelines. This will reduce the number of different applications for PDC programs and related funding assistance. Suggested changes have been submitted to PDC for its review and approval and will then go to the Board for final signoff. Once board approved, the PDC will send out communications regarding ICRM/TCP activities and the PDC scholarship process and related deadlines.

The ZRA hosted **Exam Prep Workshop series** was approved by the Board of Directors and is scheduled for **November 8-10, 2021** (separate from the Annual Conference this year). The ICRM Exam Prep Agreement offers ZRA a 50/50 profit share and will be advertised to all current candidates of the Institute in addition to ZRA. Full details will be provided soon.

CONCERNS EXPRESSED ABOUT THE USE OF THE TERM "ACCESSION" WITHIN THE ZIMS SYSTEM

The subject of "accession" and "acquisition" came up recently on the ZRA listserv and we feel ZRA members – especially newer ones – would benefit from a discussion of the terms and their use (and the use of corresponding terms "deaccession" and "disposition") with regard to electronic databases. This is a very esoteric subject, but the primary concerns seem to be:

- 1. clearly defining/understanding whether an individual or group (specimen) is acquired or accessioned by an institution, i.e., defining an individual institution's responsibility for a specimen, and
- 2. understanding that assigning an identification number (in a database or in paper records) is not the same as accessioning.

Based on international professional practice (Appendix A), *accession* is defined as "the formal process used to accept and record an item as an object".^[1] Similarly, *deaccession* is the process by which an object is removed from the collection and the record archived. We had advocated in the early design of ZIMS that the terms "acquisition" and "disposition" be employed for entering and transferring animals in the database and leave "accession" and "deaccession" up to the institution. It is not appropriate for any specimen collection to be "accessioned" into ZIMS - it is simply a shared database in which animals are recorded and, unlike an institution, has no legal standing with respect to the individual animals. Though ZIMS assigns what is termed a Global Accession Number (GAN) to an entity when an animal or group enters the ZIMS system, it is not appropriate.)

As used within ZIMS, accession is "recording a new animal or group into the ZIMS database."^[2] The movement of an individual or group from one institution to another is considered to be a transfer between institutions and not a new accession. Therefore, in the ZIMS lexicon, all holders can acquire individuals or groups, but only the first can 'accession' them. Similarly, an entry of a disposition (a "transfer") does not constitute the documentation of the end of an institution's responsibility ("deaccession"). Deaccession is a process undertaken by the institution, with a ZIMS entry being only a portion of that process – a portion that does not convey the finality or meaning of deaccession. Even after entry of a disposition in ZIMS, the deaccession may not be complete until all final information, e.g., necropsy information, is included in the institution's records.

In ZIMS there is no clear end of the first institution's accession of an individual/group, i.e., deaccession – the point at which it is no longer part of that institution's permanent collection. Since one cannot deaccession in ZIMS, the deaccession by one institution can only be inferred by accession by a subsequent holder – yet the next ZIMS holder by definition cannot record an accession because the animal was already accessioned by the first holder with the initial transaction. A fine Gordian knot.

As noted by the Listserv discussion, there is confusion as to whether an institution is accessioning a specimen into the institution's collection or merely acquiring it when recording the event in ZIMS. The general presumption (reinforced in *Best Practices for Accessions in ZIMS* by the repeated and incorrect use of 'accession') seems to be that each and every specimen will/should be accessioned at each institution. However, now is an appropriate moment to acknowledge that there are situations where an institution holds animals that are not/should not be accessioned into its collections. Institutional policy might have a different set of responsibilities for different situations, such as for staff pets or injured wildlife that are held for temporary treatment or care. The use of "collection" in ZIMS allows creating a record without actually "accessioning". 'Main collection' is usually used for those individuals/groups which are

intended to be accessioned upon acquisition and deaccessioned when both title and possession are relinquished; other 'collections', e.g., 'research' or 'education', can then be utilized for animals that are merely 'acquired' for non-collection purposes. Assigning a different local numbering system for such animals would highlight the different responsibility for these animals.

(Additional to the above-noted confusion is the complication created by the Association of Zoos and Aquariums (AZA) mis-use of these important terms in the document *AZA Policy on Responsible Population Management*: 'acquisition' is used when obtaining any specimens; 'transfer' when moving specimens to other institutions; and 'dispose/disposing' for permanent destruction of a specimen. But that could be another treatise entirely.)

While the ARKS program was in use, there was only one institution per record – 'my record is for this animal only while at my facility' – so we (generally) used the term 'accession' in an appropriate manner. A specimen came into our collection and it left: it was accessioned, then eventually deaccessioned. The presumption was that each specimen recorded in ARKS was accessioned and it would have had a paper record set documenting the accession; there probably were cases where specimens were not accessioned into the permanent collection (only acquired) but, nevertheless, entered into the ARKS database merely as a convenient record system. However, ZIMS creates one continuous record for an animal, comprised of its time at multiple institutions. Now, we need to be more precise in our terminology.

A NO WORRIES IMPORTATION OF CAPTIVE BRED BIRDS FROM GERMANY

Well, okay, maybe a few worries – but this importation went well. The goal was to import 40 Madagascar sacred ibis (*Threskiornis bernieri*) and 20 Madagascar pond herons (*Ardeola idae*) from Weltvogelpark Walsrode located in Germany. All birds were captive bred at Weltvogelpark, in colonies descended from parents collected from the wild between 2003-2005.

In support of IUCN's recommendations, and as outlined in their 2020 Regional Collection Plan, AZA's Ciconiiformes, Phoenicopteriformes and Pelecaniformes (CP&P) Taxon Advisory Group advocates refocusing North American breeding efforts from the IUCN Least Concern sacred ibis (*Threskiornis aethiopicus*) to the IUCN Endangered Madagascar sacred ibis (*Threskiornis bernieri*). The TAG also suggested replacing IUCN Least Concern cattle egret (*Bubulcus ibis*) in North American zoo habitats with Madagascar pond heron (*Ardeola idae*), also listed as IUCN Endangered.

While Harrison Edell, TAG Chair, and our Curatorial Assistant, Ali Rackley, worked on transaction agreements, I started the permit search. I was positive I would find CITES listings for Madagascar natives. After pulling up nothing on my USFWS Species Search with both scientific and common names, I checked CITES and WBCA listings and still found nothing. This was so unexpected, I asked Registrars from other zoos participating in the importation to check my work. They too found nothing for CITES and WBCA.

As odd as it sounds, all we needed was a USDA import permit. We applied for the USDA permit and Ali arranged quarantine space. A broker was hired to clear the shipment with US customs at first point of entry into the US (New York) and a courier booked to transport the birds in a temperature-controlled vehicle large enough to accommodate 24 crates from New York to Dallas. On November 23, 2020, 59 birds (12.7 Madagascar pond herons and 20.20 Madagascar sacred ibis) entered the US for the first of a 60-day quarantine with 30-day federal quarantine in New York, with only one shipping injury. On Christmas Eve, 57 birds were transported safely by a commercial ground shipper with a 30-day quarantine at Dallas (unfortunately, an ibis and heron died during the USDA quarantine).

Upon clearing quarantine at Dallas, birds were sent on Ioan to conservation partners at Houston Zoo, San Diego Zoo, San Diego Zoo Safari Park, Santa Barbara Zoo, Oakland Zoo, and ZooTampa. Dallas has set up breeding groups for both species as well.

Challenges included:

- 24 beautiful (but expensive) crates built by Weltvogelpark for the shipment (ibis were 2 birds/crate and herons were 5 birds/crate);
- the courier had to rent an appropriate vehicle to transport the birds;
- difficulty reaching USDA Quarantine station to make arrangements with lots of back and forth communication to arrange for species-appropriate husbandry while in federal quarantine;
- USDA requiring the birds out of federal quarantine by December 24 as they would be closed for the Christmas holiday; and,
- the flight from Germany being rescheduled twice.

Fortunately, the birds arrived on the very last day within the logistics window and Ali could relax on Christmas Day!


Hello Brandon
