- Jenn Wilson, President, called the meeting to order. Reviewed the responsibilities of the Board of Directors
- Decisions made over the past year:
  - o Approved committee documents, routine approvals
  - o Signed 2026 Annual Conference host agreement
  - o TCP overhaul process complete, launch
  - o New website online, largely complete
  - o Approved Standing Rules for Treasurer, Ethics Committee
  - o Approved Marketing and Outreach Committee promotional opportunities
  - Adding AZA and federal standards
  - o Created organizational chart
  - Election for two Board positions
  - Approved Transport Taskforce
- Next Year's Projects: finalize Strategic Plan, continue to improve website functionality, pursue general liability insurance
- Treasurer: Association is solvent. Total income to Date \$19,155.13, Total expense \$15,041.78. Ended fiscal year with balance in checking of \$11,775.37. Savings interest \$12.35. Balance in savings \$55,018.87. Cash on hand \$66, 794.24.

- Transport Taskforce (Ian Shelley): State agency directory is available, moving on to vendor catalog
- Annual Conference Committee (Joann Watson)
  - o Successful 2025 Annual Conference in Miami, 105 attendees from 94 institutions
  - Refined use of Whova app, strengthened planning timeline, enhanced Call for Presentations, and developed updated Host Institution Guidelines
  - Work already in progress for 2026 Annual Conference
- Bylaws Committee (Mary Noell)
  - No requests for edits, deletions or additions to the Bylaws to work on and present to the membership.
  - o Karsyn McCreedy now serving as Vice Chair
- Ethics Committee (Rebecca Hoover): Updated Standing Rules
- History Committee (Jasmine Alvarado)
  - Developed a new template to help conference organizers and the History Committee determine what documents and other materials need to be submitted to the ZRA archive
  - o Assisting with the ZRA History timeline for the new website
  - o Chair and Vice Chair positions will be open the following year, 2026
  - o Historical documents were shipped to the Milwaukee County Zoo, ZRA Archive
- Marketing and Outreach Committee (Laurie Patel)
  - o New ZRA Stickers in two sizes to be handed out at the conference on Friday.
  - o Work email signature mini campaign to link to ZRA
  - o Continued work on Non-ZRA member outreach list
  - o Future plans include selling ZRA branded swag at the next conference in 2026. There will also be pre orders before the conference. Also, going to other conferences and represent ZRA to recruit new members.

  - Four applicants received funds from PDC scholarships to attend Annual Conference in Miami

  - Short-term goals to distribute AZA accreditation survey via Zoho, revice AZA Accreditation Guide for Registrars
